In connection with the above - referred matter, I hereby submit the report as under:

- 1. In compliance with the above referred MCA circulars, the Company had sent the Notice along with the Statement under Section 102 of the Act setting out material facts in respect of the resolution mentioned therein electronically by email to all the members of the Company, whose names appeared on the register of members / list of beneficial owners as received from the KFin Technologies Limited (Registrar & Share Transfer Agent) as on 30<sup>th</sup> September, 2024 (Cut-Off Date).
- 2. The Company completed the dispatch of notice by e-mail on Thursday, 3<sup>rd</sup> October, 2024. In accordance with the MCA Circulars, no physical copy of the Notice, Postal Ballot Form and pre-paid business reply envelope was dispatched to the members. Therefore, the Company was not required to provide the facility of voting through physical postal ballot.
- 3. The Company had published advertisements in Financial Express (English) and Loksatta (Marathi), newspapers on Thursday, 3<sup>rd</sup> October 2024, regarding the completion of the dispatch of Notice and also specifying therein the matters prescribed in the Rules with regard to remote e-voting.
- 4. The remote e-voting period commenced on Friday, 4<sup>th</sup> October, 2024 from 9:00 A.M. (IST) onwards and ended on Sunday, 3<sup>rd</sup> November, 2024, 5:00 P.M. (IST), both days inclusive for the purpose of postal ballot, via e-voting platform facilitated by National Securities Depository Limited ("Authorized Agency/ NSDL") to provide remote e-voting facility viz.: <u>www.evotinq.nsdl.com</u>.

- 5. The members of the Company holding shares as on the cut-off date were entitled to vote on the resolution as contained in the Notice and have voted through the e-voting facility only as per the MCA circulars. Members have cast their votes on the designated platform, viz.: <u>www.evoting.nsdl.com</u>.
- The remote e-voting was unblocked on Monday, 4<sup>th</sup> November 2024, after 11:00
  A.M. (IST) in the presence of two witnesses who are not in employment of the Company.
- 7. Thereafter. the details containing, *inter-alia*, list of the members, who voted "For" or "Against" on the resolution were derived from the report generated from the e-voting platform provided by the Authorised Agency in respect of voting through remote e-voting.
- 8. The members have cast their votes through remote e-voting for resolution set out in said Notice, and all votes cast up to Sunday, 3<sup>rd</sup> November, 2024, 5:00 P.M. (IST), i.e., the last date and time fixed by the Company for postal ballot process have been considered for the purpose of this report.
